The AFRI Coalition (Coalition), which represents a diverse array of scientific societies and agricultural science stakeholder organizations united in support of the USDA's Agriculture and Food Research Initiative (AFRI), respectfully requests that you make AFRI, the nation's premiere competitive research program in applied and fundamental agricultural science, a priority in the FY 2011 appropriations bill. The Coalition believes that robust funding of AFRI shows strong commitment to America's farmers, consumers, and food and rural entrepreneurs, bringing them the tools necessary to maintain the country's competitiveness. At the same time, work performed through AFRI helps to protect the natural resource base and environment, enhance human nutrition, and foster vibrant rural communities.

The AFRI Coalition supports funding the program at the fully authorized level of \$700 million as soon as practicable. Furthermore, USDA Secretary Vilsack has testified before Congress that "underlying the achievement of all of the Department's goals is a strong research program."
